Molymet Belgium is committed towards quality, safety & health, environment and operational excellence through their know-how, the development of their employees and the use of world class technology.

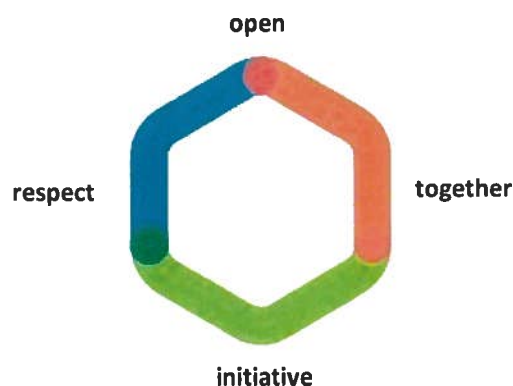
In addition we aim to value proposition for the different stakeholders:

- open communication with all employees by raising awareness, mutual consultation and participation.


Molymet Belgium commits to pursue a safe and healthy working environment. All employees of Molymet Belgium comply with the agreements and procedures relating to safety and health.
